### CHECKLIST FOR ALL DEMOLITIONS The Department of Planning & Zoning

1. Determine size of building to be demolished. Height, Width & Length = CU FT.
2. Complete APPLICATION FOR DEMOLITION PERMIT.
3. Obtain signature of property owner/manager on application form.
4. Complete UTILITY CUT OFF FORM: All utility cut offs must be signed by a representative of said utility.

**NOTE: YOU MUST NOTIFY WATER AND SEWER BEFORE YOU BEGIN DEMOLITION. IF YOU FAIL TO NOTIFY WATER AND SEWER, YOU WILL BE RESPONSIBLE FOR ANY DAMAGE TO TAPS OR METERS.**

5. Complete DEMOLITION DEBRIS DISPOSAL FORM

Ohio EPA now requires all demolition debris to be placed in a Licensed EPA approved site.

**NOTE: NO SITE WITHIN THE CITY OF CONNEAUT IS APPROVED FOR DISPOSAL OF DEMOLITION DEBRIS.**

6. Show proof of DEMOLITION INSURANCE BOND
7. Inspection of (1) cavity, (2) sanitary cap or septic and (3) final after grading, must be completed before bond will be released. Please call Department of Planning & Zoning to schedule inspections.

### DEMOLITIONS ORDERED BY THE CITY

If demolition is by order of the City and the City enters into contract with the contractor, the contractor must first sign the contract with the City in the City Manager's office. Steps 1 thru 7 must then be completed.
